Republic of Serbia has received financing from the World Bank toward the cost of the Enabling Digital Governance Project (EDGE), and intends to apply part of the proceeds toward payments under the contract for Connectivity for E- Government. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The Office for Information Technologies and Electronic Government (OITeG) now invites sealed Bids from eligible Bidders for Connectivity for E- Government. The purpose is:
  - Improvement of Government ICT network of the state institutions
  - Enhancement of the ICT security
  - Enhancement of the throughput of Government ICT network

Delivery, installation and testing of the equipment are included in the scope of the work as well as support during warranty period.
