- Configuration, integration and commissioning of Internet routers and aggregation switches.
- Configuration and integration of Firewall devices and systems for monitoring and management, commissioning and policy adjustment.
- Configuration of DC access switches, configuration of interfaces for servers.
- Configuration and adjustment of SFPs, including cabling between the offered devices, which requires optical and copper cables of the Bidder's obligations.

- Installations and configurations of security gateway solutions

The bidder should organize and conduct employee training with the contracting authority in the form of knowledge transfer for technologies that are the subject of public procurement for all offered equipment and software of this phase for 5 days for 6 hours a day. The training program will be coordinated by the representatives of the Bidder and the Purchaser.
